SUBJECT: Update on Proposition 68, Parks and Water Bond Act of 2018 Funds

STAFF RECOMMENDATION:

Staff recommends the RCRPD Board review the information regarding Proposition 68 funding.

EXECUTIVE SUMMARY:

There have been no significant updates since the last RCRPD 10/3/18 meeting regarding proposition 68 fund allocations. In review of the last update for the per capita (non-competitive) program, draft guidelines will be presented for public review and comment in the fall of 2018. Also in fall of 2018, the state will begin determining allocations, as well as resolving situations where two or more eligible entities serve the same populations. In the spring or summer of 2019, allocations will be announced, a final guide will be released, and grant administration workshops will be available for eligible entities. The RCRPD Board is again encouraged to review the competitive grant programs from Prop 68 funds for additional funding beyond the per capita program.

SUBJECT: Senate Bill 1029

STAFF RECOMMENDATION:

Staff recommends the RCRPD Board review the information regarding Senate Bill 1029.

EXECUTIVE SUMMARY:

The California Senate unanimously approved Senate Bill 1029 on August 22, 2018 to create "The Great Redwood Trail", which would turn the 300-mile long railway no longer in use by the North Coast Railroad Authority (NCRA) into a trail, connecting San Francisco to Arcata. The northern segment, from Willits to Arcata, would be transferred to the Great Redwood Trail Agency, and the southern segment managed by the Sonoma Marin Area Trail Agency, in which the NCRA would then be dissolved through SB 1029. Once completed, the trail is projected to have a significant positive impact on economies in north coast communities. California outdoor recreation generates over \$92 billion per year, is responsible for nearly 700,000 jobs with over \$30 billion in wages, and brings over \$6 billion in tax revenues to state and local communities. The NCRA has significant financial debt, which would need to be resolved as a first step, and Senator Mike McGuire is continuing to meet with state government agencies, land owners, trail advocates, and transportation officials on a plan to work out the NCRA's financial debt and devise a plan to move forward with the trail system.

FISCAL IMPACT:

None at this time, but anticipated revenues from tourism when trail is finished.
